Terms of Adoption

This dog is entrusted to you on the strict understanding that the following conditions are read and agreed:

1. The dog should wear a collar and identity disc bearing your telephone number at all times
2. If at the time of adoption the adopted dog has not already been neutered, I understand that it must be done at the earliest opportunity with a veterinary practice approved by **Just for Dogs** and that the adopted dog/bitch **MUST NOT** be used for breeding purposes
3. Annual booster vaccinations be kept up to date throughout the dogs life, and prompt qualified veterinary treatment must be sought in cases of injury or illness. Please note that any future expenses, veterinary or otherwise (exclusive of neutering), are no longer the responsibility of **Just for Dogs** once adoption has taken place, unless such costs have been agreed at the time of adoption. The centre strongly advises new owners to arrange appropriate insurance cover against veterinary treatment and third party liability
4. The dog should not be allowed to roam and in the event of the adopted dog going lost or missing, both **Just for Dogs** and the police should be informed within four hours
5. To feed and house the dog to the satisfaction of **Just for Dogs**. If it is intended that an adopted dog is to sleep outside, it must be made clear at the time of adoption. Permission will only be granted when a member from **Just for Dogs** has viewed and approved the intended accommodation
6. To exercise the dog regularly and only chain the dog when absolutely necessary, at which time a running chain should be used
7. Permit an authorised member of **Just for Dogs** to visit your premises from time to time to be assured that the dog is happily settled
8. Allow **Just for Dogs** to repossess the dog if, in the opinion of an authorised member, the terms of this agreement are not reasonably been adhered to
9. To agree **NOT TO PART WITH** or **TO HAVE DESTROYED** the adopted dog without first notifying Just For Dogs as a more suitable alternative could be actioned.
